



**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)
And Recommending Approval**

RESOLUTION No. 21 series of 2017

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of 500 Pieces Monoblock Classroom Armchair No. 17-05-224 with an Approved Budget for the Contract of One Million Five Hundred Thousand Pesos (Php 1,500,000.00) in the PhilGEPS and in a conspicuous place at the premises of Cebu Normal University;

WHEREAS, representatives from the following prospective bidders came to attend the Pre-Bid Conference conducted on May 29, 2017 but was not called to order due to non-quorum of the Bids and Awards Committee:

1. Sentinel Plastics Manufacturing Corp.
2. Cebu Progress Commercial
3. Spring Events and Production

WHEREAS, Bid Bulletin No. 1 was issued and published changing the name of the project into Procurement of 500 Pieces Plastic Tablet Classroom Armchair with modifications of the technical specifications and scheduling another Pre-Bid Conference on June 14, 2017 and re-scheduling the Bid Opening Conference to June 27, 2017;

WHEREAS, during the re-scheduled Pre-Bid Conference conducted on June 14, 2017, only representative from Sentinel Plastics Manufacturing Corp. came to attend and purchased the Bidding Documents;

WHEREAS, Sentinel Plastics Manufacturing Corp. dropped its eligibility documents and financial proposal during the Bid Opening Conference on June 27, 2017;

WHEREAS, Sentinel Plastics Manufacturing Corp. was rated "PASSED" in the eligibility checking of documents, hence; the envelope containing its financial/bid proposal was opened and the amount of bid as read was One Million Four Hundred Forty Thousand Pesos (Php 1,440,000.00);

WHEREAS, the Technical Working Group conducted a post-qualification evaluation process on the documents and technical specifications submitted by the lone bidder, Sentinel Plastics Manufacturing Corp., and was found compliant, hence; was post-qualified;

WHEREAS, Sentinel Plastics Manufacturing Corp. submitted the post-qualification requirements on time;




NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:






