RESOLUTION No. 28 series of 2020

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Office Supplies for Modular Learning Scheme for AY 2020 - 2021 with Bid No. 20-08-247 with an Approved Budget for the Contract of Nine Hundred Three Thousand Six Hundred Fifty Pesos (Php 903,650.00) in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 26 series of 2020 dated September 2, 2020 declared the bid submitted by **Trimax Computer Supplies and General Merchandise** as the **Lowest Calculated Bid (LCB)**;


