**BAC Resolution Declaring Single Calculated Responsive Bidder (SCRB)
and Recommending Approval and Award**

RESOLUTION No. 23 series of 2020

WHEREAS, Cebu Normal University posted an Invitation to Bid for the **Procurement of ICT Equipment for the SPED Center of the College of Teacher Education (Re-Bid)** with Bid No. 20-01-001 with an Approved Budget for the Contract of **One Million Two Hundred Twenty Thousand Pesos (Php 1,220,000.00)** in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, the Procurement of ICT Equipment for the SPED Center of the College of Teacher Education (Re-Bid) with Bid No. 20-01-001 comprised the following Lots with their corresponding Approved Budget, to wit:

Lot 1 - ICT Equipment and Accessories	Php 905,000.00
Lot 2 - Audio Video Equipment with Installation	Php 55,000.00
Lot 3 - One Unit Braille Printer	Php 260,000.00;

WHEREAS, BAC Resolution No. 20 series of 2020 dated August 3, 2020 declared the bids of Trimax Computer Supplies and General Merchandise for **Lot 1 – ICT Equipment and Accessories** in the amount of **Nine Hundred Two Thousand Four Hundred Pesos (902,400.00)** and **Lot 2 – Audio Video Equipment with Installation** in the amount of **Fifty-four Thousand Four Hundred Pesos (54,400.00)** as the Single Calculated Bids;

WHEREAS, Trimax Computer Supplies and General Merchandise was compliant to the eligibility requirements and submitted the documents on time as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;




