BAC Resolution Declaring Single Calculated Responsive Bidder (SCRB) and Recommending Approval and Award

RESOLUTION No. 22 series of 2020

- WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Rackmount Firewall Appliance with 3-Year License (Re-Bid) with Bid No. 20-01-047 with an Approved Budget for the Contract of One Million Two Hundred Thousand Pesos (P 1,200,000.00) in the PhilGEPS, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;
- WHEREAS, BAC Resolution No. 19 series of 2020 dated July 27, 2020 declared the bid of Skynet Digital Systems Inc. as the Single Calculated Bid in the amount of Nine Hundred Forty-five Thousand Pesos (\$\mathbb{P}\$ 945,000.00);
- WHEREAS, Skynet Digital Systems Inc. was compliant to the eligibility requirements and submitted the documents on time as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
