**BAC Resolution Declaring Disqualification of the Bidders,
Failure of Bidding and Recommending for a Re-advertisement and Approval**

RESOLUTION No. 34 series of 2020

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and Facilities for CY 2021 with Bid No. 20-09-338 with an Approved Budget for the Contract of Five Million Eight Hundred Ninety-seven Thousand One hundred Thirty-eight Pesos and Ninety-one Centavos (**P 5, 897, 138.91**) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, in response to the said invitation, representatives of the following prospective bidders attended the online Pre – Bid Conference conducted on November 3, 2020 via Zoom Platform:

1. Café Security Agency Inc.;
2. Topcom Security Agency Inc.;

WHEREAS, the following prospective bidders purchased the bidding documents and dropped their eligibility documents and financial proposals before the deadline on November 16, 2020, to wit:

1. Café Security Agency Inc.;
2. Topcom Security Agency Inc.;
3. Gaprotec Security Inc.;

WHEREAS, representatives of the above-mentioned bidders attended the eligibility checking of documents and the opening of bids conducted on November 16, 2020 at the EMMA Center, Cebu Normal University;

WHEREAS, during the eligibility checking of documents, Café Security Agency Inc., Topcom Security Agency Inc., and Gaprotec Security Inc. were compliant to all the requirements specified in the Bidding Documents; hence, were rated "PASSED";

WHEREAS, the envelopes containing the financial proposals of the following eligible bidders were opened and read; to wit:

WHEREAS, the members of the Bids and Awards Committee and the Technical Working Group (TWG) conducted the Bid Evaluation and the Amounts of Bid as Calculated of the eligible bidders mentioned above are as follows:

WHEREAS, during the conduct of the Bid evaluation, it is further discovered by the members of the Technical Working Group that in the computation of SSS Employer Share and PHIC Employer Share of Topcom Security Agency Inc., Gaprotec Security Agency, and Cafe Security Agency Inc. are not compliant to the said mandatory government contributions. Additionally, Café Security Agency quoted "Class C" for guards to be detailed to Balamban and Medellin wherein the Bid Docs stated that it be "Class B". Thus, the members of the Technical Working Group recommended to the Bids and Awards Committee for the disqualification of the Bids submitted by the three Security Agencies;

WHEREAS, upon careful examination, validation and verification of all the eligibility/technical and financial requirements, as well as the recommendation of the TWG, Topcom Security Agency Inc., Gaprotec Security Agency, and Cafe Security Agency Inc. are not compliant to the mandatory government contributions, thus, non-responsive and disqualified;

WHEREAS, considering that all three bidders fail to successfully provide the required monthly contributions to SSS and PhilHealth, there is failure of bidding for the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and Facilities for CY 2021;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

1. To declare Topcom Security Agency Inc., Gaprotec Security Agency, and Cafe Security Agency Inc. **non-compliant** in their financial proposals, thus, disqualified;
2. Declare failure of bidding and recommend for the re-advertisement and approval of the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and Facilities for CY 2021.


