BAC Resolution Declaring Disqualification of the Bidders, Failure of Bidding and Recommending for a Re-advertisement and Approval

RESOLUTION No. 35 series of 2020

- WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2021 Bid No. 20-09-339 with an Approved Budget for the Contract of Five Million Five Hundred Twenty-one Thousand Four Hundred Fifty-three Pesos and Twenty Centavos (Php 5,521,453.20) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;
- WHEREAS, in response to the said invitation, representatives of the following prospective bidders attended the online Pre Bid Conference conducted on November 3, 2020 via Zoom Platform:
 - 1. Starcom Manpower and Allied Services, Inc.;
 - 2. CBII Philippines International, Inc.;
- WHEREAS, the following prospective bidders purchased the bidding documents and dropped their eligibility documents and financial proposals before the deadline on November 16, 2020, to wit:
 - 1. CBII Philippines International, Inc.:
 - 2. Starcom Manpower and Allied Services, Inc.;
- WHEREAS, representatives of the above-mentioned bidders attended the eligibility checking of documents and the opening of bids conducted on November 16, 2020 at the EMMA Center, Cebu Normal University;
- WHEREAS, during the eligibility checking of documents, CBII Philippines International, Inc. and Starcom Manpower and Allied Services, Inc. were compliant to all the requirements specified in the Bidding Documents; hence, were rated "PASSED";
- WHEREAS, the envelopes containing the financial proposals of the following eligible bidders were opened and read; to wit:

WHEREAS, the members of the Bids and Awards Committee and the Technical Working Group (TWG) conducted the Bid Evaluation and the Amounts of Bid as Calculated of the eligible bidders mentioned above are as follows:

- WHEREAS, during the conduct of the Bid evaluation, it is further discovered by the members of the Technical Working Group that both bidders are non-compliant to the standard administrative fee of not less than ten percent (10%) of the total contract cost per DOLE Department Order No. 174, series of 2017 Section 11.b).ii. Moreover, CBII Philippines International Inc. is non-compliant in terms of Class B per PHIC table for 2021 and SSS premium for Class A per SSS table for 2019 and Starcom Manpower and Allied Services, Inc. uses P970.00 for Class A on SSS premium which is higher than what is required and also uses P610.00 for Class B SSS premium which is lower than the required. Thus, the members of the Technical Working Group recommended to the Bids and Awards Committee for the disqualification of the Bids submitted by the two prospective bidders;
- WHEREAS, upon careful examination, validation and verification of all the eligibility/technical and financial requirements, as well as the recommendation of the TWG, CBII Philippines International Inc. and Starcom Manpower and Allied Services, Inc. are not compliant to the mandatory 10% administrative overhead per DOLE issuance, thus, non-responsive and disqualified;
- WHEREAS, considering that all two bidders fail to successfully provide the required administrative overhead and the monthly contributions to SSS and PhilHealth, there is failure of bidding for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2021 Bid No. 20-09-339;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- 1. To declare CBII Philippines International, Inc., and Starcom Manpower and Allied Services, Inc. **non-compliant** in their financial proposals, thus, disqualified;
- 2. To declare failure of bidding and recommend for the readvertisement and approval of the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2021.
