**BAC Resolution Declaring Disqualification of the Bidder,
Failure of Bidding and Recommending for a Re-advertisement and Approval**

RESOLUTION No. 37 series of 2020

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Year Subscription of 300 MBPS Dedicated Leased Line Bid No. 20-11-429 with an Approved Budget for the Contract of Three Million Six Hundred Thousand Pesos (Php3,600,000.00) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, in response to the said invitation, representatives of the following prospective bidders submitted Letter of Intent and attended the Pre – Bid Conference conducted online via Zoom Platform on December 4, 2020:

1. RISE, Inc.;
2. Radius Telecoms, Inc.;

WHEREAS, only Radius Telecoms, Inc. purchased the bidding documents and dropped its eligibility documents and financial proposal before the deadline on December 16, 2020;

WHEREAS, representative of the above-mentioned prospective bidder attended the eligibility checking of documents and the opening of bids conducted on December 16, 2020 at the EMMA Center, Cebu Normal University;

WHEREAS, during the checking of eligibility documents, the Bids and Awards Committee found Radius Telecoms, Inc. not compliant, hence, was rated "FAILED" based on the following grounds:

- 1) Failure to provide a valid Certificate of PhilGEPS Registration. The submitted Certificate of PhilGEPS Registration is valid only until December 3, 2020;
- 2) Failure to provide the original of the Omnibus Sworn Declaration.


NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
