TERMS OF PAYMENT

1. The winning bidder shall send a monthly billing to CNU based on the number of examinees being administered on a certain month, this shall be the basis for payment of its services.

2. During the months of April and June 2021, the winning bidder must provide all the tests results (alpha and rank), as the basis for payment of its services.

- Online tests that will be provided by the winning bidder should be standardized. Hence, CNU – Testing Center will be asking any proof from the manual of such test/s with regard to the reliability and validity of such test/s.
- 5. Technical Working Group (Dean of Student Affairs and Testing Director) will be given an online schedule from the bidders in order to check on the items and description of such online test/s that they will be providing.
- Winning bidder is duly authorized to conduct online testing services as an entity. Thus, CNU – Testing Center will be asking any proof of such authority to do so.
- During test administration by the winning bidder, the one who will administer should be a Registered Psychometrician coming from the winning bidder entity.

TERMS OF PAYMENT

- The winning bidder shall send a monthly billing to CNU based on the number of examinees being administered on a certain month, this shall be the basis for payment of its services.
- During the months of April and June 2021, the winning bidder must provide all the tests results (alpha and rank), as the basis for payment of its services.

ADDENDUM (as of February 11, 2021 based from the Pre-bid Conference)

 The winning bidder shall send testing result/s (soft copy) on a particular month based on the

examinees being administered (alpha list only), as basis for payment of its services. Such copy should be signed by a Registered Psychometrician/Registered Psychologist/Registered Guidance Counselor. 4. At the end of the testing services, the winning bidder shall send (soft and hard copies) of the alpha and rank listings of all examinees per program/s. (e.g., Alpha and Rank Listings of all examinees of the Kindergarten). Such copies should be signed by a Registered Psychometrician/Registered Psychologist/Registered Guidance Counselor.
