The Cebu Normal University, through the General Appropriations Act and Special Trust Fund of 2021 intends to apply the sum of Three Million Six Hundred Thousand Pesos (Php 3,600,000.00) being the ABC to payments under the contract for Procurement of One Year Subscription of 300 MBPS Dedicated Leased Line (Re-Bid) with Bid No. 21-01-010A. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Cebu Normal University* now invites bids for the above Procurement Project.Delivery of the Goods is required by *Twelve (12) Months*.
