**BAC Resolution Declaring Single Calculated Responsive Bidder (SCRB)
and Recommending Approval and Award**

RESOLUTION No. 33 series of 2020

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Twelve (12) Months Contract to Provide Clerical and General Services with a 6-Day Work per Week from January to December 2021 with Bid No. 20-09-324 with an Approved Budget for the Contract of Five Million Eight Hundred Sixteen Thousand Thirteen Pesos and Twelve Centavos (Php 5,816,013.12) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 30 series of 2020 dated November 5, 2020 declared the bid of **LSERV Corporation** as the Single Calculated Bid in the amount of **Five Million Seven Hundred Eighty-two Thousand Eight Hundred Ninety-six Pesos and Ninety-six Centavos (Php 5,782,896.96)**;

WHEREAS, **LSERV Corporation** was compliant to the eligibility requirements and submitted the documents on time as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, upon careful examination, validation and verification of all the eligibility documents, financial proposal, technical specifications and post-qualification documents submitted by **LSERV Corporation**, the Single Calculated Bid, its bid was found to be responsive and thus post-qualified;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


