**BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and
Recommending Approval and Award**

RESOLUTION No. 28 series of 2021

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Year Subscription of 300 MBPS Dedicated Leased Line (Re-Bid) Bid No. 21-01-010A with an Approved Budget for the Contract of Three Million Six Hundred Thousand Pesos (Php 3,600,000.00) in the PhilGEPs website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 23 series of 2021 dated March 4, 2021 declared the bid of **Innové Communications, Inc.**, in the amount of **One Million Five Hundred Fifty-four Thousand Six Hundred Forty-eight Pesos (Php 1,554,648.00)** as the Lowest Calculated Bid (LCB);

WHEREAS, **Innové Communications, Inc.** was compliant to the eligibility requirements and submitted on time the documents required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
