**BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and  
Recommending Approval and Award**

**RESOLUTION No. 33 series of 2021**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot Office Supplies with Bid No. 21-01-022 with an Approved Budget for the Contract of One Million Eight Hundred Forty-Two Thousand Nine Hundred Forty-Seven Pesos and Thirty-Three Centavos (Php 1,842,947.33) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

**WHEREAS**, BAC Resolution No. 32 series of 2021 dated April 13, 2021 declared the bid of **Trimax Computer Supplies and General Merchandise** in the amount of **One Million Seven Hundred Twenty-seven Thousand One Hundred Twenty-six Pesos (₱ 1,727,126.00)** as the **Lowest Calculated Bid (LCB)**;

**WHEREAS**, **Trimax Computer Supplies and General Merchandise** was compliant to the eligibility requirements and submitted on time the documents required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;




