**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)  
and Recommending Approval and Award**

**RESOLUTION No. 12 series of 2021**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the project One Lot Concreting of Driveway with Covered Pathwalk in CNU Balamban Campus Bid No. 20-10-399 with an Approved Budget for the Contract of Seven Million Pesos (Php 7,000,000.00) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

**WHEREAS**, BAC Resolution No. 41 series of 2020 dated December 28, 2020 declared the bid of **Petrina Construction and General Merchandising** as the Single Calculated Bid in the amount of **Six Million Nine Hundred Eighty-nine Thousand Eight Hundred Fifty-nine Pesos and Twenty-eight Centavos (Php 6,989,859.28)**;

**WHEREAS**, **Petrina Construction and General Merchandising** was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;

**WHEREAS**, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of **Petrina Construction and General Merchandising** compliant; hence, declared post-qualified and responsive for the project One Lot Concreting of Driveway with Covered Pathwalk in CNU Balamban Campus Bid No. 20-10-399.
