BAC Resolution Declaring Failure of Bidding and Recommending for Cancellation of Procurement of Equipment for the Upgrading of the CNU Science Laboratory (Lot 1- Bid No.: 21-06-299; Lot 2- Bid No.: 21-06-300; Lot 3- Bid No.: 21-06-301; Lot 4- Bid No.: 21-06-302; Lot 5- Bid No.: 21-06-303; Lot 6- Bid No.: 21-06-304; ABC – P 31, 826, 850.00)

RESOLUTION No. 50 series of 2021

WHEREAS, the Cebu Normal University posted an Invitation to Bid for the Procurement of Equipment for the Upgrading of the CNU Science Laboratory (Lot 1- Bid No.: 21-06-299; Lot 2- Bid No.: 21-06-300; Lot 3- Bid No.: 21-06-301; Lot 4- Bid No.: 21-06-302; Lot 5- Bid No.: 21-06-303; Lot 6- Bid No.: 21-06-304 in the PhilGEPS website, in the website of Cebu Normal University and in a conspicuous place within the premises of Cebu Normal University with approved budget of the contract of thirty-one million eight hundred twenty-six thousand eight hundred fifty pesos (P 31, 826, 850.00);

WHEREAS, the following prospective bidders submitted Letters of Intent and their representatives attended the Pre – Bid Conference conducted physically at EMMA Center and online via ZOOM Platform on July 27, 2021; to wit:

WHEREAS, in the conduct of the Pre-Bid Conference, concerns pertaining to the specifications of the items and/or equipment to be procured were identified;

WHEREAS, after the conduct of the pre-bid conference, TWG/End-User sent a letter request to the BAC through the BAC Chair notifying of the several changes in the specifications and inclusion of other equipment that were omitted and further request for the re-

advertisement due to change in the specifications, additional equipment and change in the approved budget of the contract ;

WHEREAS, Section 36.5 of the Implementing Rules and Regulation of the Republic Act 9184 authorizes the BAC to cancel or terminate the conduct of procurement activities for a justifiable reason. Section 36.5 provides,

35.6 Without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to: a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;

WHEREAS, the present circumstance of the above-mentioned procurement falls squarely on the above-cited provision. There will be material change in the specifications of the items to be procured. Should the current procurement activity will proceed, it will thereafter declare failure since no supplier can comply with the specifications provided since the equipment is not available in the market. Additionally, the approved budget of the contract will substantially increase due to the inclusion of omitted equipment and this move is further adopted to save time, effort and expense for the procuring entity and that of the prospective bidders.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare failure of bidding in the Procurement of Equipment for the Upgrading of the CNU Science Laboratory;
- b) To recommend for the cancellation of the Purchase Request and Requisition Form and revise in accordance with the correct specifications and it is further recommended that end-users shall revise their respective Purchase Request and Requisition Form; and
- c) To Cancel the Current Procurement Activity and to Conduct New Bidding for the Procurement of Equipment for the Upgrading of the CNU Science Laboratory.
