**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)
and Recommending Approval and Award**

RESOLUTION No. 8 series of 2022

WHEREAS, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2022 Bid No. 21-10-613 with an Approved Budget for the Contract of Five Million Five Hundred Forty-four Thousand Fifty-five Pesos and Eighty-eight Centavos (Php 5,544,055.88) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

WHEREAS, BAC Resolution No. 2 series of 2022 dated January 4, 2022 declared the bid of **CBII Philippines International, Inc.** as the Single Calculated Bid in the amount of **Five Million Five Hundred Forty-four Thousand Fifty-two Pesos and Fifty-six Centavos (Php 5,544,052.56)**;

WHEREAS, **CBII Philippines International, Inc.** was compliant to the eligibility requirements and submitted the documents as required under the provision of Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184 on time;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of **CBII Philippines International, Inc.** compliant; hence, declared post-qualified and responsive in the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2022 with Bid No. 21-10-613.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


