**BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and  
Recommending Approval and Award**

**RESOLUTION No. 15 series of 2022**

**WHEREAS**, Cebu Normal University posted an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and External Campuses for CY 2022 with Bid No. 21-10-625 with an Approved Budget for the Contract of Five Million Eight Hundred Ninety-six Thousand Ninety-eight Pesos and Twenty-nine Centavos (Php 5,896,098.29) in the PhilGEPS website, in the CNU website and in a conspicuous place within the premises of Cebu Normal University;

**WHEREAS**, BAC Resolution No. 4 series of 2022 dated January 19, 2022 declared the bid submitted by **Café Security Agency Inc.** in the amount of **Five Million Eight Hundred Thirty-eight Thousand Three Hundred Twenty-six Pesos and Sixty-four Centavos (P 5,838,326.64)** as the Lowest Calculated Bid (**LCB**);

**WHEREAS**, **Café Security Agency Inc.** was compliant to the eligibility requirements and submitted on time the documents required under Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or under Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

**WHEREAS**, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of **Café Security Agency Inc.** compliant; hence, declared post-qualified and responsive in the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and External Campuses for CY 2022 with Bid No. 21-10-625.

**NOW THEREFORE**, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid submitted by **Café Security Agency Inc.** as the **Lowest Calculated Responsive Bid (LCRB)** in the Procurement of One Lot One Year Contract to Provide Security Guard (Services for the CNU Buildings, Premises and External Campuses for CY 2022 with Bid No. 21-10-625; and
