BAC Resolution Declaring Single Calculated Responsive Bid (SCRB) and Recommending Approval and Award

RESOLUTION No. 3 series of 2023

- WHEREAS, Cebu Normal University through the General Appropriations Act and Special Trust Fund of 2023 posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2023 Bid No. 22-10-805 with an Approved Budget for the Contract of Seven Million Five Hundred Eighty Thousand Four Hundred Nineteen Pesos and Twenty Centavos (P 7,580,419.20);
- WHEREAS, BAC Resolution No. 78 series of 2022 dated December 27, 2022 declared the bid submitted by CBII Philippines International, Inc. in the amount of Seven Million Five Hundred Eighty Thousand Four Hundred Nineteen Pesos and Twenty Centavos (P 7,580,419.20) as the Single Calculated Bid (SCB) for the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2023 with Bid No. 22-10-805;
- WHEREAS, CBII Philippines International, Inc. was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
- WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of CBII Philippines International, Inc. compliant; hence, declared responsive and post-qualified in the Procurement of One Lot One Year Contract to Provide Janitorial Services for CNU for CY 2023 with Bid No. 22-10-805.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
