BAC Resolution Declaring Single Calculated Responsive Bid (SCRB) and Recommending Approval and Award

RESOLUTION No. 2 series of 2023

- WHEREAS, Cebu Normal University through the General Appropriations Act and Special Trust Fund of 2023 posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot Twelve (12) Months Contract to Provide Clerical and General Services with a 6-Day Work per Week from January to December 2023 Bid No. 22-10-873 with an Approved Budget for the Contract of Six Million Seven Hundred Seventeen Thousand Seven Hundred Eighty-three Pesos and Thirty-six Centavos (P 6,717,783.36);
- WHEREAS, BAC Resolution No. 77 series of 2022 dated December 27, 2022 declared the bid submitted by LSERV Corporation in the amount of Six Million Seven Hundred Seventeen Thousand Seven Hundred Eighty Pesos (\$\mathbb{P}\$ 6,717,780.00) as the Single Calculated Bid (\$CB) for the Procurement of One Lot Twelve (12) Months Contract to Provide Clerical and General Services with a 6-Day Work per Week from January to December 2023 with Bid No. 22-10-873;
- WHEREAS, LSERV Corporation was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
- WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of LSERV Corporation compliant; hence, declared responsive and post-qualified in the Procurement of One Lot Twelve (12) Months Contract to Provide Clerical and General Services with a 6-Day Work per Week from January to December 2023 with Bid No. 22-10-873.
