**BAC Resolution Declaring Single Calculated Responsive Bids (SCRB) per Lot
and Recommending Approval and Award**

RESOLUTION No. 75 series of 2022

WHEREAS, Cebu Normal University through the General Appropriations Act of 2023 posted an Invitation to Bid in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University for the Procurement of Twelve (12) Months Internet Subscription for All Campuses Bid No. 22-10-825 with the total Approved Budget for the Contract (ABC) of Five Million Six Hundred Forty Thousand Pesos (P 5,640,000.00): Lot 1 – CNU Balamban, One Million Two Hundred Thousand Pesos (P 1,200,000.00); Lot 2 - CNU Medellin, One Million Two Hundred Thousand Pesos (P 1,200,000.00); Lot 3 – College of Medicine, One Million Two Hundred Thousand Pesos (P 1,200,000.00) and Lot 4 - CNU Main Campus, Two Million Forty Thousand Pesos (P 2,040,000.00);

WHEREAS, BAC Resolution No. 74 series of 2022 dated December 19, 2022 declared the bids submitted by Converge Information and Communications Technology Solutions, Inc. for Lot 1 – CNU Balamban Campus in the amount of Two Hundred Eighty-eight Thousand Pesos (P 288,000.00), for Lot 3 – CNU College of Medicine in the amount of Two Hundred Eighty-eight Thousand Pesos (P 288,000.00) and for Lot 4 – CNU Main Campus in the amount of Five Hundred Forty Thousand Pesos (P 540,000.00) as the Single Calculated Bids (SCB) per Lot in the Procurement of Twelve (12) Months Internet Subscription for All Campuses with Bid No. 22-10-825;

WHEREAS, Converge Information and Communications Technology Solutions, Inc. was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
