**BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and
Recommending Approval and Award**

RESOLUTION No. 10 series of 2023

WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot Office Supplies (1st Quarter) Bid No. 23-01-002 with an Approved Budget for the Contract of One Million Two Hundred Forty-six Thousand Four Hundred Eighty-three Pesos and Thirty-three Centavos (P 1,246,483.33);

WHEREAS, BAC Resolution No. 7 series of 2023 dated February 20, 2023 declared the bid submitted by **Trimax Computer Supplies and General Merchandise** as the Lowest Calculated Bid (LCB) in the amount of **One Million Two Hundred Forty-six Thousand Four Hundred Forty-six Pesos (P 1,246,446.00)**;


WHEREAS, **Trimax Computer Supplies and General Merchandise** was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of **Trimax Computer Supplies and General Merchandise** compliant; hence, declared post-qualified and responsive in the Procurement of One Lot Office Supplies (1st Quarter) with Bid No. 23-01-002.


NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


