BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and Recommending Approval and Award

RESOLUTION No. 20 series of 2023

- WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot ICT Supplies and Consumables (STF 1st Quarter) Bid No. 23-01-097 with an Approved Budget for the Contract of Seven Hundred Seventy-four Thousand Seven Hundred Twenty-eight Pesos and Thirty-one Centavos (₱ 774,728.31);
- WHEREAS, BAC Resolution No. 19 series of 2023 dated March 30, 2023 declared the bid submitted by OfficeBox Enterprises in the amount of Six Hundred Twenty-seven Thousand Seven Hundred Thirty-two Pesos (₱ 627,732.00) as the Lowest Calculated Bid (LCB);
- WHEREAS, OfficeBox Enterprises was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
- WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of OfficeBox Enterprises compliant; hence, declared post-qualified and responsive in the Procurement of One Lot ICT Supplies and Consumables (STF 1st Quarter) with Bid No. 23-01-097.

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid submitted by OfficeBox Enterprises as the Lowest Calculated Responsive Bid (LCRB) in the Procurement of One Lot ICT Supplies and Consumables (STF - 1st Quarter) with Bid No. 23-01-097; and
