**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)

RESOLUTION No. 16 series of 2023

WHEREAS, Cebu Normal University through the General Appropriations Act of 2023 posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot Subscription to Multidisciplinary Research Database Bid No. 22-11-922 with an Approved Budget for the Contract (ABC) of One Million One Hundred Ninety-five Thousand Pesos (₱ 1,195,000.00);

WHEREAS, BAC Resolution No. 13 series of 2023 dated March 2, 2023 declared the bid submitted by LibTech Source Philippines, Inc. as the Single Calculated Bid (SCB) in the amount of One Million One Hundred Ninety-five Thousand Pesos (₱ 1,195,000.00) for the Procurement of One Lot Subscription to Multidisciplinary Research Database with Bid No. 22-11-922;

NOW THEREFORE, we the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


