BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and Recommending Approval and Award

RESOLUTION No. 18 series of 2023

- WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot Additional Access Points for CNU Campus Bid No. 23-01-095 with an Approved Budget for the Contract of Two Million Seven Hundred Thousand Pesos (₱ 2,700,000.00);
- WHEREAS, BAC Resolution No. 17 series of 2023 dated March 15, 2023 declared the bid submitted by Microdata Systems and Management, Inc. in the amount of Two Eight Hundred Thirty-five Thousand Four Hundred (P 2,435,800.00) as the Lowest Calculated Bid (LCB);
- WHEREAS, Microdata Systems and Management, Inc. was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
- WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid of Microdata Systems and Management, Inc. compliant; hence, declared post-qualified and responsive in the Procurement of One Lot Additional Access Points for CNU Campus with Bid No. 23-01-095.
