**BAC Resolution Declaring Single Calculated Responsive Bid (SCRB)
and Recommending Approval and Award**

RESOLUTION No. 55 series of 2023

WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of Infant Simulator and Simulation Learning Management System for the College of Medicine: Lot 1 – One (1) Unit Infant Simulator with Basinet (ABC - ₱ 7,500,000.00) No. 23-07-566 and Lot 2 - One (1) Lot Simulation Learning Management System (ABC - ₱ 16,000,000.00) No. 23-06-525 with a total Approved Budget for the Contract (ABC) of Twenty-three Million Five Hundred Thousand Pesos (₱23,500,000.00);

WHEREAS, BAC Resolution No. 54 series of 2023 dated August 22, 2023 declared the bid submitted by Aspen Multi-System Corp. for Lot 1 – One (1) Unit Infant Simulator with Basinet in the amount of Seven Million Four Hundred Ninety-four Thousand Pesos (₱ 7,494,000.00) and for Lot 2 - One (1) Lot Simulation Learning Management System in the amount of Fifteen Million Nine Hundred Ninety-four Thousand Pesos (₱ 15,994,000.00) as the Single Calculated Bids (SCB) in the Procurement of Infant Simulator and Simulation Learning Management System for the College of Medicine: Lot 1 – One (1) Unit Infant Simulator with Basinet No. 23-07-566 and Lot 2 - One (1) Lot Simulation Learning Management System No. 23-06-525;

WHEREAS, Aspen Multi-System Corp. was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, after the Post-Qualification Evaluation process, the Technical Working Group and the Bids and Awards Committee found the bid submitted by Aspen Multi-System Corp. compliant; hence, declared post-qualified and responsive in the Procurement of Infant Simulator and Simulation Learning Management System for the College of Medicine: Lot 1 – One (1) Unit Infant Simulator with Basinet No. 23-07-566 and Lot 2 - One (1) Lot Simulation Learning Management System No. 23-06-525.


