BAC Resolution Declaring the Failure of Negotiated Procurement (Two-Failed Biddings) of Petroleum, Oil and Lubricant Products at Retail Pump Price for CNU Main, Balamban and Medellin Campus

RESOLUTION No. 27 series of 2024

- WHEREAS, Cebu Normal University, thru the Bids and Awards Committee (BAC) posted an Invitation for Negotiated Procurement (Two-Failed Biddings) for the Procurement of Petroleum, Oil and Lubricant Products at Retail Pump Price for CNU Main, Balamban and Medellin Campus with Bid No. 24-01-003 in the PhilGEPS website, CNU website and in conspicuous place within the premises of Cebu Normal University with an Approved Budget for the Contract (ABC) of One Million Two Hundred Thirty-Three Thousand Six Hundred Eighty Pesos (£ 1,233,680.00);
- WHEREAS, the Bids and Awards Committee (BAC) declared a first (1st) failed bidding under BAC Resolution No. 11 series of 2024 dated February 6, 2024;
- WHEREAS, on February 29, 2024, the second (2nd) failure of bidding was declared per BAC Reso. No. 20, series of 2024 and was approved to proceed with the Negotiated Procurement as per Section 53.1 (Two Failed Biddings) of the 2016 Revised IRR of R.A. 9184;
- WHEREAS, during the scheduled Negotiation Meeting held on March 11, 2024, held at the BAC Office, Cebu Normal University, no prospective bidders attended the proceeding;
- WHEREAS, copies of the Invitation for Negotiated Procurement were also sent manually to all prospective bidders from the CNU's Registry of Suppliers:
- **WHEREAS**, from March 6-13, 2024, no prospective bidder had purchased the Bidding Documents;
- WHEREAS, on the deadline for the submission and opening of best offer/s or negotiation proposals, on March 13, 2024, no bidder submitted its best offer for the project;



- a) To declare the FAILURE OF NEGOTIATED PROCUREMENT (Two-Failed Biddings) for the Procurement of Petroleum, Oil and Lubricant Products at Retail Pump Price for CNU Main, Balamban and Medellin Campus with Bid No. 24-01-003 pursuant to Section 35.1.a of the IRR of R.A. 9184: and
- b) To recommend to the HoPE the approval of declaring the Failure of Negotiated Procurement (Two-Failed Biddings) for the Procurement of Petroleum, Oil and Lubricant Products at Retail Pump Price for CNU Main, Balamban and Medellin Campus, and approval for the re-posting as provided in Section 54.2 and Annex H of the 2016 Revised IRR of R.A. 9184, after the End-User's conduct of the mandatory review and evaluation of the terms, conditions and specifications of the project, including its cost estimates.
