CONTRACT EXTENSION
(2023 Contract Agreement for Clerical Services)

KNOW ALL MEN BY THESE PRESENTS:

This Contract Extension ("**Contract**") was made and executed by and between:

CEBU NORMAL UNIVERSITY, a higher education institution duly organized and existing under the laws of the Philippines created by virtue of Republic Act 8688 otherwise known as "The CNU Charter", with principal office address at Osmeña Blvd., Cebu City, and represented herein by its President, **DR. DANIEL A. ARIASO, SR.**, hereinafter referred to as the "**UNIVERSITY**",

- and -

LSERV CORPORATION, a corporation duly organized and existing under Philippine laws, with business address at 21st Floor, Petron Mega Plaza, 358 Sen. Gil Puyat Ave., Makati City represented by its President, **JOSEPH V. ANGELES**, hereinafter referred to as the "**AGENCY**",

Collectively referred to as the "**Parties**".

WHEREAS, a Contract of Services was made by and between the above-named Parties on the 14th day of February (hereinafter referred to as the "original contract") notarized by Atty. Selwin M. Prada on the said date and recorded as Doc. No. 6; Page 3; Book XLVI; Series of 2023;

WHEREAS, the above-cited contract is for the period February 1, 2023-December 31, 2023, and may be extended upon its expiration subject to the same terms and conditions;

WHEREAS, to ensure continuity of service and avoid any interruption of services rendered by the employees of LSERV Corporation during the pendency of the procurement process awaiting the completion of the procurement process and approval by the CNU Board of Regents, there is a need to extend the existing contract for security services between Cebu Normal University and LSERV Corporation;

NOW, THEREFORE, in consideration of the mutual promises herein, the parties, intending to be legally bound, hereby agree to extend the Contract for General and Clerical Services with LSERV Corporation until the completion of the procurement process for AY 2024 provided it shall not exceed three months.

The parties reaffirm that no other terms or conditions of the above-mentioned original contract that are not hereby otherwise modified or amended shall be negated or changed as a result of this here-stated extension and addendum.


