WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot Office Supplies for CNU Various Offices for First Quarter 2024 with Bid No. 23-11-864 with an Approved Budget for the Contract (ABC) of One Million One Hundred Five Thousand Eight Hundred Eighty-Six Pesos and Thirty-Six Centavos (₱ 1,105,886.36);







