

**CONTRACT EXTENSION**  
(2023 Contract Agreement for Janitorial Services)

**KNOW ALL MEN BY THESE PRESENTS:**

This Contract Extension (“**Contract**”) was made and executed by and between:

**CEBU NORMAL UNIVERSITY**, a higher education institution duly organized and existing under the laws of the Philippines created by virtue of Republic Act 8688 otherwise known as “The CNU Charter”, with principal office address at Osmeña Blvd., Cebu City, and represented herein by its President, **DR. DANIEL A. ARIASO SR.**, hereinafter referred to as the “**UNIVERSITY**”,

- and -

**CBII PHILIPPINES INTERNATIONAL, INC.**, a company duly incorporated under the laws of the Republic of the Philippines with business address at 8771 Unit C, Santol Street, San Antonio Village, Makati City, represented herein by its President, **REYNALDO M. CUEVAS** hereinafter referred to as the “**AGENCY**”.

Collectively referred to as the “**Parties**”.

**WHEREAS**, a Contract of Services was made by and between the above-named Parties on the 15<sup>th</sup> day of February 2023 (hereinafter referred to as the “original contract”) notarized by Atty. Wilmar K. Requina on the said date and recorded as Doc. No. 284; Page 58; Book 5; Series of 2023;

**WHEREAS**, the above-cited contract is for the period February 2023-December 2023 and may be extended upon its expiration subject to the same terms and conditions;

**WHEREAS**, to ensure continuity of service and avoid any interruption of services rendered by the janitors of CBII during the pendency of the procurement process awaiting the completion of the procurement process and approval by the CNU Board of Regents, there is a need to extend the existing contract for security services between Cebu Normal University and CBII;

**WHEREAS**, the parties desire to extend the contract and amend some terms and conditions set forth in this “Contract;”

**NOW, THEREFORE**, in consideration of the mutual promises herein, the parties, intending to be legally bound, hereby agree to extend the Contract for Janitorial Services with CBII until the completion of the procurement process for AY 2024 provided it shall not exceed three months;


The parties reaffirm that no other terms or conditions of the above-mentioned original contract that are not hereby otherwise modified or amended shall be negated or changed as a result of this here-stated extension and addendum.






