BAC Resolution Declaring Lowest Calculated Responsive Bid (LCRB) and Recommending Approval and Award

RESOLUTION No. 6 series of 2024

- WHEREAS, Cebu Normal University posted in the PhilGEPS website, in the CNU website and in conspicuous places within the premises of Cebu Normal University an Invitation to Bid for the Procurement of One Lot One Year Contract to Provide Security Guard Services for the CNU Buildings, Premises and Facilities for CY 2024 with Bid No. 23-10-836 with an Approved Budget for the Contract (ABC) of Nine Million One Hundred Forty One Thousand Five Hundred Forty Six Pesos and Forty-Eight Centavos (\$\mathbb{P}\$ 9,141,546.48);
- WHEREAS, representatives from prospective bidders, including Gaprotec Security Inc. and Café Security Agency Inc., attended the Pre-Bid Conference on November 23, 2023, at the BAC Office, Cebu Normal University;
- WHEREAS, both Gaprotec Security Inc. and Café Security Agency Inc. initially met the eligibility requirements and submitted acceptable technical proposals, with same financial bids of Nine Million Eighty-Four Thousand Two Hundred Ninety-Six Pesos and Eighty-Eight Centavos (₱ 9,084,296.88), below the ABC, making them both having the Lowest Calculated Bid;
- WHEREAS, BAC Resolution No. 89 series of 2023 declared both Gaprotec Security Inc. and Café Security Agency Inc. as the Lowest Calculated Bid (LCB);
- WHEREAS, both bidders, being LCB, underwent post-qualification evaluation;
- WHEREAS, BAC Resolution No. 1, series of 2024 declared Gaprotec Security Inc. Post-Disqualified in the bidding for the security services contract due to the DOLE's issuance of the Certificate of Pending Cases to Gaprotec Security Inc. dated December 21, 2023;
- WHEREAS, BAC Resolution No. 5, series of 2024 denied the Motion for Reconsideration filed by Gaprotec Security, Inc.;
- WHEREAS, Café Security Agency, Inc. was compliant to the eligibility requirements and submitted on time the documents required in Section II. Instructions to Bidders of the Bidding Documents, No. 20. Post-Qualification (20.2) or Section 34.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;
