# SECURITY SERVICES CONTRACT

## KNOW ALL MEN BY THESE PRESENTS:

This Security Service Agreement made and entered into by and between:

**CEBU NORMAL UNIVERSITY**, a higher education institution duly organized and existing under the laws of the Philippines created by virtue of Republic Act 8688 or otherwise known as "The CNU Charter", with principal office address at Osmeña Blvd., Cebu City, and represented herein by its President, **DR. LAURENCE L. GARCIA**, hereinafter referred to as "**CNU**",

-and-

**CAFÉ SECURITY AGENCY, INC.**, duly organized and existing under and by virtue of the laws of the Philippines, with office address at Café-Gonzales Bldg., N. Bacalso Ave., Talisay City, Cebu, represented by its President/General Manager, **MR. JUSTO S. CAFE**, hereinafter referred to as "**AGENCY**",

Collectively referred to as "**PARTIES**".

WITNESSETH:

**WHEREAS**, CNU contemplates to engage the services of a private security services agency, for the purpose of preventing unauthorized persons from entering the premises, safeguarding and protecting the perimeter, buildings, vehicles, machineries, equipment, supplies, materials and other properties and such other offices and facilities of CNU as may be determined from time to time against theft, robbery, pilferage, sabotage and other unlawful acts including the protection of all personnel and its clients within the guarded premises.

**WHEREAS**, the AGENCY is engaged in the business of rendering private security services throughout the Philippines and is duly licensed as such by the Philippine National Police in accordance with Republic Act No. 5487 as amended, and has offered to provide CNU with Private Security Guards for the purpose above mentioned and the offer of the AGENCY has been accepted by CNU.

**NOW, THEREFORE**, for and in consideration of the premises and of the terms, conditions and stipulations hereunder set forth, the PARTIES hereto have agreed and do hereby agree as follows:

## 1. SCOPE OF WORK

1.1. The AGENCY shall render provide well-groomed and mindful of proper hygiene security services at Cebu Normal University located at Osmeña Blvd., Cebu City and its external campuses situated in Balamban, Poblacion Medellin, and Antipoloi Medellin, Cebu, repectively:



- a. Twenty-Four (24) (Class A) Security Guards for Day and Night shift for main Campus, Osmeña Blvd., Cebu City
- b. Five (5) (Class B) Security Guards for Day and Night shift for Poblacion Medellin Campus
- c. Four (4) (Class B) Security Guards for Day and Night shift for Anipolo Medellin Campus
- d. Five (5) (Class B) Security Guards for Day and Night shift for Balamban Campus

The number shall decrease or increase at the discretion of CNU when the exigency of the service so requires or when the situation demands.

- 1.2. All security guards shall possess the qualification prescribed in Section 5 of Republic Act No. 5487 and Presidential Decree No. 11 dated October 3, 1972 and Presidential Decree 11-A dated January 1973 as well as the Implementing Rules and Regulations promulgated by the Philippine National Police.
- 1.3. The Security personnel shall work eight (8) hours a day, for seven (7) days a week. There shall be three shifts of 8-hours work per day. In case of shortage of relievers, the guards shall cover temporarily the post of the absent guard provided that in the event of extension, the extension shall not extend beyond eight hours in a single tour of duty.
- 1.4. The AGENCY shall, prior to actual posting of guards, submit to CNU the Biodata, NBI Clearance, Medical Records, PNP License and Behavior Analysis Report (Neuro-Psychological Exam) of each guard who will be assigned to CNU.
- 1.5. CNU shall have the right to refuse any employment and/or substitution of any guard prior to the assignment or during his tour of duty.
- 1.6. The AGENCY shall provide CNU with qualified, bonded, uniformed and armed security guards and shall assign the corresponding number of security guards per area;
- 1.7. The AGENCY shall equip each detailed guard with uniform, licensed firearm, equipment and other paraphernalia for the use of the guards when actually on post as prescribed by pertinent laws and regulations;
- 1.8. The AGENCY shall ensure that all guards must meet the Term of Reference (TOR) minimum qualifications, including the PNP/SOSIA License, medical, drug test, neuro-psych clearance, training certificates on first aid, BLS, disaster preparedness, fire and earthquake training, and fully vaccinated status as applicable.
- 1.9. To ensure that guard posts are always manned during the time required and observed, the AGENCY shall maintain and make available the guard relievers or replacements when the need arises, such as, in case



of absence, but in case of shortage of relievers, the AGENCY shall have the option to extend the working hours of any guard provided that in the event of such extension, the total working hours of the guard shall not extend beyond eight (8) hours for any single tour of duty;

- 1.10. The AGENCY shall be responsible for compliance with RA 5487 as amended and shall be solely liable for any claim made by the guards assigned to the premises under the Labor Code of the Philippines, Social Security Law, various Presidential Decrees on Allowances and wage orders, all their implementing rules and regulations which are presently existing or which may hereafter be promulgated by governing authorities.

**2. KEY PERFORMANCE INDICATORS (KPI) and RESPONSIBILITIES**

- 2.1. The Security Agency shall ensure continuous and effective protection of the University's personnel, students, visitors and property, through the deployment of qualified, licensed, and security personnel, equipped with necessary tools, communication, and monitoring equipment.

The performance of the Security Agency shall be measured against the following Key Performance Indicators (KPI):

Key Performance Indicators	Performance Measure	Target
1. Guard presence and attendance	Percentage of post manned 24/7	100%
2. Incident response time	Time from incident to first response	5 minutes
3. Client satisfaction	Rating by end-user based on quarterly survey	At least 90%
4. Compliance with labor and statutory benefits	Zero COA or DOLE violations	100% compliance

A rating of Below Satisfactory for two consecutive quarters constitutes ground for contract review or termination.

- 2.2. The AGENCY shall assign their guards post duties on rotation basis following their duty schemes to avoid familiarity and shall furnish CNU a monthly report of incidences and observations affecting campus security and all related matters.
- 2.3. The AGENCY shall assume full responsibility for any loss, damage, personal injury or death due to theft, robbery, pilferage, trespass, misconduct or connivance of the guards and other unlawful acts which CNU, its students, employees, patrons, and any other persons may suffer during watch hours of detailed security guards, provided that it shall have been established after due investigation that said loss, damage, personal injury, or death was principally due to the negligence or fault

of the guard. The investigation shall be conducted by the committee constituted and shall be completed within forty-eight (48) hours.

- 2.4. The AGENCY shall assume complete responsibility and liability for any loss or damage or injury to CNU properties, its students, employees, guest, third person and their properties which have been duly turned over and received by the AGENCY; or its authorized representative except in case of force majeure or fortuitous events or under following circumstances:
- i. In case where the loss, damage occurs inside a closed office and/or building into which AGENCY or its agents have no access, the AGENCY shall not be liable except when it is shown that the door or any part of the building/facilities or office was forcibly opened and that such loss or damage is reported to the AGENCY within 24 hours from the discovery thereof.
  - ii. The AGENCY shall not be liable when the item(s) reported lost were small and can easily be hidden inside the pocket and where CNU had not expressly required and authorized the searching of all personnel and personnel vehicles and or any kind of visitor(s) of CNU, who enter and leave the establishments and premises.
- 2.5. The AGENCY assumes responsibility for losses, damages, or injuries caused by negligence, misconduct, or omission of its personnel. CNU may withhold payments or deduct losses corresponding to the amount of damage.
- 2.6. The AGENCY provides biometric machines for Main Campus, Medellin and Balamban at no cost.
- 2.7. The AGENCY agrees to deploy two (2) head guards as liason officers free of charge.
- 2.8. The AGENCY shall coordinate with CNU for the 3-day orientation to be conducted by CNU and failure to provide guards prior to the deployment is ground for termination.
- 2.9. The AGENCY agrees to hold CNU, its officers, directors, stockholders and employees, free and harmless from any accident, damage claims or suit of whatever nature that may be brought or filed by any of CNU's students, employees, guests arising from the operation of the AGENCY's security services. In the event that CNU is held liable for any such accidents, loss, claim or damage by court or administrative action or other proceeding, AGENCY shall reimburse CNU for such loss, claim or damage which CNU may be required to pay. This is in addition to such reasonable amount of attorney's fees and other costs and expenses incurred by CNU in defending itself.
- 2.10. The AGENCY guards are not employees of CNU and as such, CNU shall not be responsible for any claim for personal injury or damage including death caused to any of the guards or to any third party where



such injury or death arises out of or sustained in the course of the performance of guard duties by said guards.

- 2.11. The AGENCY shall faithfully serve the interest of CNU in rendering services and shall not, during the period of this Agreement, or anytime thereafter, use or disclose to any unauthorized person, firm or entity, any information, derogatory or otherwise, concerning the business affairs of CNU or any other information which the members of the security force of the AGENCY may have acquired by reason of their assignment to CNU. Commission of dishonest acts perpetrated by the AGENCY personnel; directly against CNU, regardless of value, same shall be a ground for outright contract termination, forfeiture of appropriate bond and exclusion from joining future bidding.
- 2.12. In the event that CNU, its students, employees and/or guests suffers any loss, or damage to the property or in the event that any of CNU's students, employees, guests or any other persons legitimately within CNU's premises suffer physical injury or death, CNU shall inform the AGENCY thereof within forty-eight (48) hours from the happening of the incident. In case of loss or damage to property, the notice to the AGENCY shall include, whenever possible, an enumeration of the items lost or damaged, together with their corresponding values. CNU shall have the right to withhold or suspend payments due to the AGENCY and/or automatically deduct from any amount due to the AGENCY that value of such loss or damage without prejudice to the CNU's right to seize the surety bond, until the losses and/or damages suffered by CNU shall have been fully compensated.
- 2.13. In the event of controversy or disagreement between CNU and the AGENCY regarding liability for the loss, damage, physical injury or death referred to in the preceding paragraphs hereof, the parties shall constitute a Committee, which shall be composed of five (5) members. CNU and the AGENCY shall each appoint two (2) members and an independent party/person who shall act as Chairperson. The decision of the committee shall be binding upon the parties, unless, within a period of thirty (30) days from receipt of the decision, a party shall institute the proper legal proceeding relating to the dispute.
- 2.14. To guarantee the faithful execution of the AGENCY's obligation under this Agreement, and the proper performance of the duties by its security guards, the AGENCY agrees to provide surety bond to be obtained from a surety company acceptable to CNU.

### 3. RESPONSIBILITIES OF CNU

- 3.1. CNU shall provide a security officer to oversee coordination with AGENCY.
- 3.2. CNU shall conduct quarterly evaluations of AGENCY performance.
- 3.3. CNU shall notify AGENCY of deficiencies, incidents or other actionable concerns.

**4. CONSIDERATION and PAYMENT TERMS**

4.1. In consideration of the Services, CNU agrees to pay the AGENCY the billing rates as provided in the monthly statement of account within five (5) days after the submission of the Statement of Account by the AGENCY. The rates quoted include the government mandatory contribution and Administrative Service Fee of 10% plus 12% Value Added Tax (VAT).

The contract rate per security personnel per month as provided in the Price Schedule ("Annex A") shall be as follows:

4.2. The AGENCY shall likewise pay their guards in cash at rate stipulated at Café Security Agency, Inc., Talisay South Central Square, Lawaan III, Talisay City, Cebu premises not later than 25<sup>th</sup> day following the services rendered from 1-15 of the month and not later than 10<sup>th</sup> day of the succeeding month for services rendered from the 16<sup>th</sup> to end of the month. Training and other activities relevant to the guards shall likewise be held at the said premises. Ammunitions spent for legitimate warning shots and expenses for repair of AGENCY's equipment due to fair wear and tear without the contributory fault or negligence of the guard shall be at the account of the AGENCY.

4.3. Should there be any wage increase in favor of the assigned personnel subsequent to the execution of the Contract pursuant to a Law, Executive Order, Decree, or Wage Order, the AGENCY is entitled to receive the same. The AGENCY, however must first inform CNU in writing on the wage increase to allow the latter to undertake the appropriate measures to address the same before its implementation.

**5. SUPERVISION AND ADMINISTRATION**

5.1. The guards and the AGENCY are in no sense employees of CNU. There is No Employer-Employee Relationship between the Parties. CNU shall not be responsible for any of the guards or to any third person where such damage, injury or death arises of said guards. Neither shall CNU be liable or responsible for any claim of the guards under labor laws and social legislation.

- 5.2. Security guards shall be hired by the AGENCY itself and this Contract shall not be deemed in any way to constitute a contract of employment between CNU and any of the security guards hired by the AGENCY but merely as contract specifying the conditions under which the security guards of the AGENCY shall render services to CNU.
- 5.3. The discipline and administration of the guards shall conform to RA 5487 and its implementing rules and regulations. Upon loss of confidence and without liability whatsoever on the part of CNU, any of the guards provided by the AGENCY may be changed immediately upon written request to that effect by CNU to the AGENCY.
- 5.4. CNU shall have the right to assign a Security Officer as overall supervisor over AGENCY's guards at any time in order to determine the quality and acceptability of the service being performed by the guards and to give policy instructions through designated AGENCY's representative on the proper safeguarding and protection of persons, places and things covered by this Agreement.
- 5.5. The AGENCY shall provide a head guard, at no cost to CNU, to act as the AGENCY's liaison in order to address the concerns of the agency personnel assigned to CNU.
- 5.6. For ready reference, the AGENCY shall provide CNU copies of unexpired license such as AGENCY license, firearms license, individual security guards license and any related licenses as far as security contracting is concerned.
- 5.7. CNU agrees to notify the AGENCY of any deficiency in the performance of guard's duties. The AGENCY shall take appropriate steps to correct the defects.


## 6. CONFIDENTIALITY AND NON-DISCLOSURE.

The Parties agree to keep confidential information and will not use for its own purpose, or without the prior written consent of the other party, disclose to any third party any information relating to the details of this Contract unless such information is required by law to be disclosed or is in the public domain other than as a result of a breach of this Section. Both parties shall agree to abide by the Data Privacy Act of 2012.

These confidentiality provisions shall apply to all confidential information exchanged between both Parties, including any exchanges occurring during preliminary discussions and negotiations. The confidentiality obligation of the Parties shall survive the termination or expiry of this Contract.

## 7. OTHER CONDITIONS.

- 7.1. The terms and conditions herein set forth shall be deemed modified by the applicable provisions of any subsequent law or decree, specifically with reference to an increase in the minimum wage and the grant of statutory occupational benefits to the workers by the Government.



- 7.2. Venue of Actions - In the event of a suit arising from this contract, the parties hereto agree that the venue of the action shall be in the Courts of Cebu City only.
- 7.3. Entirety - The Terms of Reference and all documents regarding the procurement of the Security Services are hereby expressly made an integral part of this Agreement by reference.
- 7.4. Severability - If any provision of this Contract should, for any reason, be held void or unenforceable, the legality and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired, and shall remain in full force and effect.

**8. CONTRACT DURATION**

- 8.1. This contract shall be effective from the date the Notice to Proceed is issued until December 31, 2026. In the absence of formal renewal upon expiration of the term of this contract, the same is deemed to remain enforceable on a month-to-month basis, subject to termination upon thirty (30) days prior written notice by one party to the other.
- 8.2. Notwithstanding the provisions of the preceding paragraph, CNU may terminate this contract at its sole discretion upon thirty (30) days prior written notice to the AGENCY.
- 8.3. To ensure continuity of service and avoid any interruption of service during the pendency of the procurement process for security services for year 2027, this Contract may be extended upon its expiration for three (3) months, or until the completion of the procurement process for security services for year 2027, but not more than six (6) months, subject to the same terms and conditions, after CNU makes a written notice of extension to continue the Contract, without the need for further approval from the Board of Regents of CNU.


